1. Mayor Jeter called the meeting to order.
2. Roll call was as follows:

3. Mr. Jason Murphy led the invocation.
4. Chief Carroll led the pledge of allegiance.
5. Mayor Jeter welcomed everyone to the regular meeting.
6. Public comments: Mr. Charles Elliott introduced himself as a candidate for District Judge.
7. A motion to adopt the minutes of the April 10, 2018 meeting as published was made by Alderperson Robinson, seconded by Alderperson Cloud. Motion carried.


