- 1) New Business: 1) The duties of the mayor pro tempore: After discussion and packets distributed regarding said, it was determined that Aldermen Carroll and Perkins want Danny Perkins to be signer on the checking accounts. They were notified this process has already been started. Motion that council received packets was made by Spiller, 2nd by Perkins, motion carried.
