PUBLIC HEARING MINUTES

On June 14, 2022 at 5:45pm Mayor Elizabeth Jeter and the Board of Alderman of the Village of Forest Hill conducted a public hearing at Forest Hill Municipal Complex, Room 2, 138 Blue Lake Rd, Forest Hill, LA 71430. Mayor Jeter called the meeting to order. Roll call was as follows: Present: Mayor Jeter, Alderpersons Perkins, Robinson and Carroll, quorum met; attorney Greg Jones, and Chief Carroll. Mayor Jeter read resolutions and ordinances by title: to consider levying additional or increased millage rates without further voter approval or adopting the adjusted rates after reassessment and rolling forward to rate not to exceed the prior year's maximum; Ordinance 2022-01 to Amend 2021-2022 Budget; Ordinance 2022-02 Propose 2022-2023 Budget. With no public comments or questions, public hearing was adjourned.
