PUBLIC HEARING MINUTES

On June 8, 2021 at 5:45p.m., Mayor Elizabeth Jeter and the Board of Aldermen of the Village of Forest Hill, LA conducted a public hearing at Forest Hill Municipal Complex, Room 2, 138 Blue Lake Rd, Forest Hill, LA 71430. Mayor Jeter called the meeting to order. Roll call was as follows: Present: Mayor Jeter, Alderpersons Robinson, Carroll and Perkins; and Chief Garland Carroll. Mayor Jeter explained Resolutions and Ordinances by Title: Resolutions for millage rates 2021-05 and 2021-06 regarding increase in millage rates; Ordinance 2021-02 Amend 2020-2021 Budget; Ordinance 2021-03 Propose 2021-2022 Budget. With no public comments or questions, public hearing was adjourned.

- 8) Motion to adopt financial statements as presented made by Alderperson Robinson, second by Alderperson Perkins, motion carried.
- 9) Old Business: Resolutions 2021-05 (#1) and 2021-06 (#2) to amend Millage Rate were introduced at the May 11, 2021 meeting; Public Hearing Notice was published in The Town Talk on April 25th and May 2, 2021. Res #1: motion to accept made by Robinson, second by Carroll, vote was unanimous; Res #2: motion to accept made by Robinson, second by Carroll, vote was unanimous. Ordinances were introduced at the May 11, 2021 meeting and published on May 16, 2021. 1) Ordinance 2021-02 to amend 2020-2021 budget; motion to accept made by Alderperson Robinson, second by Alderperson Carroll; motion carried. 2) Ordinance 2020-03 to propose 2021-2022 budget; motion to accept was made by Robinson, second by Perkins, motion carried. 3) Ordinance 2021-04 to Establish Control of Animals at Large and Vicious Dogs. After discussion, motion was made to table item until next month by Robinson, second by Perkins, motion carried.
