

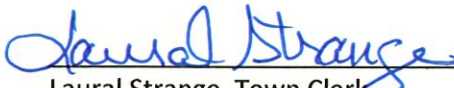

**PUBLIC MEETING MINUTES**

On Oct 14, 2025, at 6:00pm Mayor Elizabeth Jeter and the Board of Alderman of the Village of Forest Hill conducted a public meeting at Forest Hill Municipal Complex, Room 2, 138 Blue Lake Rd, Forest Hill, LA 71430. Present: Mayor Elizabeth Jeter; Attorney Greg Jones; Chief Jason Francis; Aldermen Belinda Spiller, Danny Perkins and Garland Carroll; quorum met. Mayor Jeter called the meeting to order at 6:00pm. Invocation led by Jason Murphy. Pledge led by Nick Fowlkes. Mayor Jeter welcomed everyone. Public comments on agenda items: None. Approval to adopt Sept 9, 2025 minutes as published made by Alderperson Spiller; second by Alderperson Carroll, motion unanimously carried. Approval to adopt financial statements as presented was made by Spiller, 2nd by Perkins, motion unanimously carried. New Business: 1) Representative Rhonda Butler was unable to attend meeting. 2) Nick Fowlkes presented audit report. Forest Hill had a clean audit. 3) Motion to introduce Ordinance 25-06 to increase pay increase for council members was made by Spiller, 2<sup>nd</sup> by Carroll, motion unanimously carried. 4) Motion to add item to agenda to hire police officer made by Carroll, 2<sup>nd</sup> by Perkins, motion unanimously carried. 5) Motion to rehire Albert Branch as police officer with probation period waived was made by Carroll, 2<sup>nd</sup> by Perkins, motion unanimously carried. Greg Jones, attorney, reminded everyone to complete their ethic and harassment training. There were no resident comments.
