1. Mayor Jeter called the meeting to order.
2. Roll call was as follows:
 - Present: Mayor Jeter, and Alderpersons Robinson, Danzy and Cloud.
 - Also present at the meeting: Police Chief Garland Carroll; Gregory Jones, attorney; Jason Murphy, Engineer and members of the public.
3. Jason Murphy led the invocation.
4. Jerriot Robinson led the pledge of allegiance.
5. Mayor Jeter welcomed everyone to the regular meeting.
6. Public comments – Gabby Butter complimented the road improvement on Blue Lake Rd.
7. A motion to adopt minutes of August 14, 2018 meeting as published was made by Alderperson Robinson, second by Alderperson Cloud. Motion carried.
8. A motion to adopt the financial statement as presented was made by Alderperson Robinson, second by Alderperson Danzy. Motion carried.

d. Resolution to proceed with CWF application. Motion made by Alderperson Robinson, second by Alderson Danzy; motion carried.

e. Resolution to name LGAP Authorization Form. Motion made by Alderperson Robinson, second by Alderperson Cloud; motion carried.

12. The Mayor and Board heard the monthly Police Report presented by Chief Carroll.

13. Utility Report: HH Spiller reported no issues at this time.

14. Engineer's Report – presented.

15. Attorney Report – he will proceed with annexation.

16. Fire Report –presented.

Per recommendation of Attorney, it was recommended Mayor and Aldermen go into executive session. Motion made by Alderperson Robinson, second by Alderperson Danzy. Motion carried. Regular meeting resumed on motion of Alderperson Robinson, second by Alderperson Cloud. Motion carried.


f. Hire fulltime police officer. Motion made by Alderperson Robinson, second by Alderperson Danzy, motion carried.
