Mayor Jeter read the Ordinances by title: An ordinance adopting to Amend the Compensation/Pay for the Elected Chief of Police for the Village of Forest Hill. No public comments or questions.

Mayor Jeter called the meeting to order @ 6:05pm. Roll call presented above, quorum met. Invocation led by H.H.Spiller. Pledge led by Jason Murphy. Mayor Jeter welcomed everyone. Public comments on agenda items: None. Approval to adopt August 13 2024 minutes as published made by Alderperson Spiller; second by Alderperson Carroll, motion unanimously carried. Approval to adopt financial statements as presented made by Spiller, 2nd by Perkins, motion unanimously carried. Unfinished Business: 1) To adopt Ordinance amend Chief of Police Pay motion by Carroll, 2<sup>nd</sup> by Perkins, motion unanimously carried. New Business: 1) Mr. Carroll presented the need for new hydro vac trailer and the Village of Forest Hill has LGAP funds available. The Village is looking to purchase a 500 gallon tank. Motion to proceed with looking for hydro vac trailer made Perkins, 2<sup>nd</sup> by Carroll, motion unanimously carried. 2) Mr. Carroll presented the need to purchase a new tractor to replace the 2 old tractors and presented information on tractor needed, which is under state contract. Motion to purchase Kubota diesel tractor at a cost not to exceed \$ 50,000 made by Carroll, 2<sup>nd</sup> by Spiller, motion carried unanimously. Officer Billings presented police report. Jason Murphy presented engineer report; Bryan Butter presented utility report. Greg Jones presented attorney report.
