Ordinance # 2018-03 regulating the Utility Rates for the Village of Forest Hill was introduced. Attorney Greg Jones explained Ordinance with effective date of 4/1/2018. No public comments. Public meeting was adjourned.

1. Mayor Jeter called the meeting to order.
2. Roll call was as follows:

Also present at the meeting: Police Chief Garland Carroll; Gregory Jones, attorney; H.H. Spiller, Utility Superintendent; Jason Murphy, Engineer and members of the public.
3. H.H. Spiller led the invocation.
4. Jason Murphy led the pledge of allegiance.
5. Mayor Jeter welcomed everyone to the regular meeting.
6. Public question was answered.
7. A motion to adopt minutes of February 13, 2018 meeting as published was made by Alderperson Robinson, second by Alderperson Cloud. Motion carried.

  - b. Resolution 2018-03 regarding Occupational License fees be waived in lieu of Nursery Festival fees being paid, unless vendor is on private property; the weekend of the Nursery Festival. Motion made by Alderperson Robinson; second by Alderperson Cloud. Motion carried.
  - c. Proposal to hire summer help as needed at minimum wage; maximum of 35 hours per week; no benefits. Discussion. Motion was made by Alderperson Robinson, second by Alderperson Danzy. Motion carried.
  - d. Proposal of de-annexation of Wag-A-Bag tabled as no representative of Wag-A-Bag was present.
  - e. Proposal for extra hours for Village police during Nursery Festival Thursday – Sunday. Motion made by Alderperson Robinson, second by Alderperson Cloud. Motion carried.
12. The Mayor and Board heard the monthly Police Report, There were reports of 1 possession of marijuana; 1 careless operation; 1 fraud; ; 1 sig 20 and 9 public service calls.
13. The Mayor and Board heard the monthly Utility Report presented by Mr. Spiller. No issues.
14. Engineer's Report – presented.
15. Attorney Report – None.
16. Fire Report – none.
